As you are aware, there are potential dangers associated with the posting of personally identifiable information on a website since global access to the internet does not allow us to control who may access such information. These dangers have always existed; however, we as an educationally-based non-profit do want to celebrate you, your student, and his/her work. The law requires that we ask for your permission to use information about your student. Pursuant to law, we will not release any personally identifiable information without prior written consent from you as parent/guardian.

I release all claims against JANJ with respect to copyright ownership and publication including any claim for compensation related to use of the materials.

General Guidelines: It is recommended that a release be obtained when photographing or videotaping a minor (under 18). Parent or guardian signatures are required; signatures of minors are not sufficient. When images are published, JANJ will take cautionary steps to provide minimum identifying information and will not use specific street or mailing addresses, e-mail addresses, or phone numbers. Signed release forms are not needed when subjects are in public places, such as fairgrounds or parks. Photographs or videotaping in churches or youth camps must be done only with church or camp permission and with signed release forms from participants or parent/guardian of each child. Release forms should be included in special event registration materials. It is the responsibility of the photographer or videographer to obtain signed release forms and maintain records.
